The Wilburton City Council convened in a **Regular Scheduled** Meeting held on the 13th **day of April, 2017** at **5:30p.m.** in the Wilburton City Hall Council chambers; Mayor Stephen Brinlee presiding. Rev Richard Boggs, First Christian Church, opened the meeting with a prayer followed by Mayor Brinlee leading the assembly in the Pledge of Allegiance to the flag.

PUBLIC HEARING: Mr. Danny Baldwin, Director, Kiamichi Economic Development District of Oklahoma (KEDDO), initiated the Public Hearing to determine if Wilburton should apply for the Oklahoma Department of Commerce (DOC) Community Development Block Grant (CDBG), initiated through KEDDO, for wastewater improvements as identified by the City Engineer from Information Solutions Group (replace 12 manhole covers and replace 4700 feet of pipe). Mr. Baldwin stated this grant was applied for last year; however, only 8 of the 64 submitted grants were funded. This is an opportunity to again request funding. While no matching funds from City are required, it would be helpful if the City offered a matching amount to indicate its willingness to gain the grant. A discussion followed with various points being made: those applications with matching dollars were the applications funded last year; there are parts which must be replaced, so if a grant is approved, that is less money from the working budget for the required repairs; and the city engineers will work with the City to scale back the repairs (reduce length of pipe) to allow more budget dollars for matching grant funds. It was determined the City, through KEDDO, will apply for the CDBG for wastewater improvements offering matching funds. The Public Hearing ended at 5:52pm.

7. DISCUSS AND TAKE ACTION TO APPROVE CITY LAKE RENOVATION OPTION FOR CITY LAKE RENOVATION. Dale Burke, Infrastructure Solutions Group (ISG). Mr. Burke reviewed the two National Resource Conservation Service (NRCS) options discussed in the 16 February 2017 Special City Council Meeting. He then reviewed the two options offered by his firm. He stated his conversations with the NRCS POC indicated the slip-lining option would work. NRCS engineers would require a test where a camera be inserted to ensure there are no obstructions in the pipe. Councilman Haynes asked about the cost; who pays for what? Mayor Brinlee stated 35% of cost is City's part. The time factor is now an issue; need to move forward on the project.
