4. DISCUSS AND TAKE ACTION TO APPROVE WILBURTON POLICE DEPARTMENT (WPD) POLICY GUIDE. WPD Ch Robert Bias Presenting. Ch Bias stated the current Policy Guide was last updated in 1995; therefore, there are many updates necessary. Time is critical in having a WPD Policy Guide in place; besides risking a fine if WPD is inspected, WPD lost a case last week because the information in the Policy Guide is outdated. This Policy Guide has been reviewed by OMAG. Councilman Haynes asked if this policy guide has been coordinated with the current Employee Handbook, Chapter 10, to ensure no contradictions. Ch Bias replied it had not. Councilman Littlejohn stated the City Council can address any amendments later, if necessary.
