REGULAR SCHEDULED MEETING June 15, 2021

The Wilburton City Council convened in a **Regular Scheduled** Meeting held on the **15**<sup>th</sup> **day of June 2021** at **5:30p.m.** with Mayor Stephen Brinlee, presiding. The Roll Call was conducted with the following verbal responses. All City Councilmen/women attended in person.

## **CITIZEN COMMENTS:**

There was one sign in on the Citizen Comment: Mr. Mark Showell to discuss the Budget.

## **PUBLIC HEARING**

Mayor Stephen Brinlee asked if there were any questions concerning the presented City of Wilburton FY21-22 Budget which includes the Public Works Authority (PWA) Budget.

Mr. Mark Showell asked about the Wilburton Fire Department (WFD) increase. Mayor Brinlee stated WFD now has a part time Clerk which is reflected in their budget. Mr. Showell then asked about the increase in the Street Fund budget. Mayor Brinlee stated City is purchasing more asphalt to make the many repairs needed on the Wilburton streets. The actual purchase will be placed on the Council Agenda for approval, along with a detailed plan for street repair.

Councilman Littlejohn asked about the increase of \$16,000 for PWA salaries. PWA Director Elder stated that reflected a raise to pay competitively as we are starting to lose good men when they take a job with better salary. Additionally, he has put 6 men on salary, assigning 2 each week to be on call for any after-hours needs such as water leaks, animal control calls, etc. This crew being on salary will save many overtime dollars.

Councilman Littlejohn stated he agreed with the idea; however, he thought all of the employees should receive a raise. A discussion followed as to the best way to accomplish that. City Attorney Lerblance stated they need to find new language that would reflect tying the raises to the current CPI.

Councilman Haynes asked Mayor Brinlee if there was anything he wanted to highlight, to which Mayor Brinlee stated grants received due to COVID have been very helpful in several areas: WPD, airport, City, etc.

Council President Haynes stated it appears the economy has started to improve with steadily improving tax receipts. Nationally, there appears to be funds becoming available for improving infrastructure. That means we should be ready to improve our infrastructure when funding is announced. He suggested we start looking at our needs and have a list ready. His first example is the long-standing storm drainage issue. Dir Elder stated that a survey conducted every 5 years is about to start which will identify several needs. President Haynes made the point that with the increase in income the City should complete projects which benefit the citizens and then ensure the residents are aware of the projects of improvement.

The Public Hearing closed at 5:50p.m.
