- 5. DISCUSS AND TAKE ACTION TO APPROVE INTERLOCAL AGREEMENT BETWEEN LATIMER COUNTY SHERIFF'S DEPARTMENT AND CITY OF WILBURTON POLICE DEPARTMENT (WPD).** President Haynes stated he is pleased with having the agreement especially in this new era of law enforcement where there are so many restrictions and limits. Councilman Sims stated he had the experience in a former job as a policeman of great partnerships with local agencies. It is much needed especially if your current situation causes you to travel out of your jurisdiction and yet you need to have the authority to act. This interlocal agreement will allow that: it is a "great thing to have". A discussion followed concerning the responsibilities of each agency and methods of sharing jurisdiction authority. Councilman Littlejohn suggested a conversation with WPD Ch Bias would clear up any questions.
