DISCUSS AND TAKE ACTION TO APPROVE TO SET ASIDE NOVEMBER 10 COUNCIL APPROVAL TO PURCHASE 2022 GOOSENECK TRAILER FOR \$14,196 FROM EXTREME WORK & PLAY AND APPROVE PURCHASE OF 16 FOOT GOOSENECK TRAILER FOR \$15,000 FROM EXPRESS EQUIPMENT RENTAL & SALES. Councilman Haynes asked about the premium pay received by the Senior Citizens employees from the Feed The Need Foundation and if they would also receive this premium pay. Mayor Brinlee stated those employees are considered rewarded with premium pay already and would not receive another payment from this action. Councilman Littlejohn inquired if the auditors had approved this pay and also how many employees are being paid. City Clerk Blankenship stated the auditors are aware. The premium pay will be made to 9 PWA and 10 City employees.
