The Wilburton City Council convened in a **Regular Meeting** held on the **11**th **day of May 2023** at **5:30pm** with Mayor Loran Mayes presiding: Rev Ken Harris, Sonshine Fellowship Church, led the group in prayer after which Mayor Mayes led the group in the Pledge of Allegiance. This was followed by the Roll Call conducted by the City Clerk Cindee Blankenship.

5 LATIMER COUNTY TOURISM TRUST AUTHORITY (LCTTA) UPDATE ON ODOT TRANSPORTATION ALTERNATIVE PROGRAM (TAP) & RECRETIONAL TRAILS PROGRAM (RTP) GRANTS. DISCUSSION ONLY

Ms. Magi Van Eps, Secretary, LCTTA Board, discussed the current status of the two (2) grants. The ODOT TAP Grant was not approved; application was rated 75 of 135 received. The grant will open again in January and LCTTA will again apply. The awarding of RTP Grant applications is expected to be announced after the 1st of June. Funds have been locally pledged to ensure the initiation of the trails with or without the grant Funding. Ms. Van Eps stated, "The trails are going to happen and they will bring business into Wilburton."

6. DISCUSS AND TAKE ACTION TO APPROVE HOUSING CONSTRUCTION FOR REHAB PROGRAM. REV KEN HARRIS, PRESENTING

Rev Harris gave the background for the program stating the Ministerial Alliance started a Prison Program five years ago. They visit the Latimer County Jail two times a week which has proven very successful. The problem repeatedly seen is the recovering person returns to their family home where their addiction initiated and they fall back into the bad habits. Additionally, there is "a bunch" of homeless people in Wilburton. Rev Harris then reviewed the program they are using as a standard for Wilburton to build "Sober Living Houses" to give recovering adults a chance for success by providing opportunities to work and to live in a safe environment, paying their own way. This first house will be for women followed up soon with a house for men with the third house planned for single-parent families.

They had a lot donated to them on corner of 9th & Lutie Street. He asked if the City would look at 9th Street as it is in need of repair. PWA Dir Elder said he would. They also have been given a lot located behind the Post Office and requested help in tearing down the house on the lot. City Attorney Lerblance stated the State Regulations prohibited the City from assisting demolition if the house is on private property. Rev Harris stated help with the water, any needed sewer taps, etc. would be appreciated. "We're not looking for anything free; just assistance with getting everything together." Dir Elder requested the address to verify the correct zoning.

Dir Elder led a discussion concerning the possible need to re-zone, the possible variances needed, etc. It was determined Rev Harris will contact Dir Elder and any further need for Council approval would be placed on future agendas.
