The Wilburton City Council convened in a **Special Meeting** held on the **15**<sup>th</sup> **day of March 2023** at **5:40pm** with Vice Mayor Terry Haynes presiding: Roll Call was conducted by the City Clerk.

#### 1. DISCUSS AND TAKE ACTION TO APPROVE \$374,444 FOR CITY STREETS OVERLAY

**PROJECT.** PWA Dir Mike Elder explained this is a continuation of the Overlay Project initiated in 2021, again in 2022 and earlier in 2023 for a few of the streets. Due to various issues such as asphalt plant burning down, COVID, and increased costs, he has been unable to complete the project. Dir Elder described the precise streets suggested and the cost breakdown for the project. Vice Mayor Haynes asked if the prior approval for specific streets would have to be re-approved due to the change in cost and time passed. The answer given was yes. Councilman Littlejohn asked where the funds would be taken from. City Clerk Blankenship give a breakdown of available funds in both General and Capital Improvement Funds. She also explained that some of the funds for this project have been encumbered based on prior Council approval. Dir Elder stated he would like time to present a more complete breakdown of costs at next City Council Meeting.

## 2. DISCUSS AND TAKE ACTION TO APPROVE ORDINANCE 23-1107 AMENDING ELECTED OFFICIALS' SALARIES. TABLED FEBRUARY 9, 2023

Vice Mayor Haynes discussed the change in wages as presented at February 9<sup>th</sup> City Council Meeting. City Attorney LerBlance reminded the Council that only those elected positions (Mayor, WPD Chief & Wards 1, 3, & 5 Council Members) taking office this year after the ordinance is approved will see the increase in salary. The City Clerk and Wards 2 & 4 Council Members will have to wait until there is another election to see the increase. Vice Mayor Haynes asked if the Vice Mayor should receive an extra stipend for duties in that position. City Attorney Lerblance stated the statues and ordinance provides a specific amount for council members, but not any extra pay for extra duties.

# 3. DISCUSS AND TAKE ACTION TO REVIEW AND POSSIBLY AMEND JOB DESCRITION FOR MAYOR, CITY OF WILBURTON. Vice Mayor Haynes remarked that the duties have been altered, added and supplemented over the past 16 years and needs to be reviewed for current relevancy. Dir Elder stated that through the mayor's tenure, duties and authority had been increased as the Council increased its trust in his

shown performance. It is recommended the job description revert back to the original ordinance description.

4 DISCUSS AND TAKE ACTION TO APPROVE ONE OF THREE QUOTES FOR CARPET FOR THE LATIMER COUNTY PUBLIC LIBRARY. Vice Mayor Haynes stated the two quotes received are not very clear and discussed the issues of the quotes. Dir Elder stated the Library preferred the Mission Carpet & Floors bid, stating the current carpet was installed in 1995. City Clerk Blankenship discussed the issues when Mill Creek was used at Senior Citizens Center. A discussion followed comparing the two quotes received for price and services listed. Dir Elder stated the funds would be taken from Capitol Improvement Funds. Vice Mayor Haynes asked if there is a timeline for installation to which Dir Elder remarked that will be a Library and carpet store decision.

## 5 DISCUSS AND TAKE ACTION TO APPROVE ONE OF THREE QUOTES TO PURCHASE A 40HP SUPER 105" HUSTLER ZERO TURN MOWER FOR THE STREET DEPARTMENT. Dir

Elder stated the current equipment is in bad shape and with the huge amount of mowing needed of the City's 4 right of ways, the City street easements, and the vacant lots, it is a huge job: he has someone mowing every day. With the purchase of a 104" Super Mower, one mower can do the work of two smaller ones in the same time. When asked which of the mowers he favored, Dir Elder stated that he talked to the mechanics who recommended the Vanguard motor over the Kawasaki for durability. Vice Mayor Haynes asked the length of time for delivery to which Dir Elder stated it would be 3 to 4 weeks. He also discussed the number of mowers on hand and daily maintenance program. He stated the funds would come from Capital Improvement Fund.
